A regular meeting of the Council of The Corporation of the Township of Morley was held on Tuesday, October 11th, 2022 at 7:00 p.m. in the Council Chambers with Reeve Heyens and Councillors Jolicouer and McCormick in attendance.

Councillors Armstrong and Vandenbrand were absent. Teresa Desserre Clerk-Treasurer and Public Works Bruce Nielson were also in attendance.
