A regular meeting of the Council of The Corporation of the Township of Morley was held on Monday, March 14th, 2022 at 7:00 p.m. in the Council Chambers with Reeve Heyens and Councillors Jolicouer, McCormick, Armstrong and Vandenbrand in attendance. Teresa Desserre Clerk-Treasurer and Public Works Superintendent Bruce Nielson were also in attendance.

That the Council of The Corporation of the Township of Morley support the resolution put forth from the Town of Aurora dated February 22, 2022; requesting the government of Ontario to immediately engage municipalities to determine an alternative land use planning appeals process in order to dissolve the OLT and eliminate one of the most significant sources of red tape delaying the development of more attainable housing in Ontario.

That the Council of The Corporation of the Township of Morley now rise from its in-camera session and return to open meeting.

13.) ANDREW MCCORMICK/TONY ARMSTRONG:

That the Council of the Corporation of the Township of Morley set the rates for its public works employees effective January 1st, 2022 as follows:

- i) Public Works Superintendent --\$ 31.75/hr increase of 14.37%
- ii) Grader Operator --\$ 28.00/hr increase of 12.00%
- iii) Landfill Site Operator --\$ 20.00/hr increase of 11.11%
- iv) Labourer --\$ 20.00/hr increase of 11.11%

Overtime for Public Works Superintendent, grader operator and foreman shall be paid at a rate of time and one-half for hours worked in excess of 8 hours per day, Monday through Friday, and for all hours worked on Saturdays and Sundays. Landfill site operator and labourer shall be paid overtime for hours worked in excess of 44 hours per week, at a rate of time and one-half.

****An extra \$2.00/hr will be paid when a Grader Operator works a full day while the Public Works Superintendant is away****

14.) MARIA VANDENBRAND/GARY JOLICOUER:

That the Council of The Corporation of the Township of Morley set the rates of pay for its office employees effective January 1, 2022 as follows:

- i) Clerk-Treasurer -- \$47.00/hour increase of 11.90%
- ii) Deputy Clerk-Treasurer -- \$32.00/hour increase of 6.67%

****The Deputy Clerk-Treasurer will be paid an extra \$2.00/hr when the Clerk-Treasurer is away a full day****
